

## REGISTRATION FORM

**Registration:** Application for enrollment is open to all children who meet the age requirements and can adjust to, and benefit from, the program. Children must be the **eligible entrance age** for the morning classes and/or afternoon programs for which they are seeking enrollment **by September 30, 2026** 

To register your child for the 2026-2027 school year, please submit the following to CWG-WWS:

- Completed registration form (on the reverse)
- Non-refundable registration fee of \$75 (required to hold your child's place)
- A copy of the child's birth certificate (if not previously submitted)
- Current health form, including immunizations and date of last physical (if not already on file)

**EXTENDED DAY PROGRAMS:** Children who will be 3-6 years old by September 30, 2026 are eligible for our extended day programs.

**ENROLLMENT PACKETS:** An Enrollment Packet be mailed to you in July. This packet contains forms which need to be completed and returned to us by August 1, 2026. The information that you share permits us to prepare a school environment and activities to optimize your child's experience at CWG-WWS.

## **TUITION PAYMENTS**

- The tuition for the year is divided into 10 installments due on the 1st of the month August 2026 through May 2027.
- Tuition payments can be mailed or dropped off in the office.
- Checks should be made payable to Children's Winter Garden with White Wing School (CWG-WWS) and addressed to 58 Lowell Street, Nashua, NH 03064. Please be sure to include your child's name on the check to ensure that your check is credited to the proper account.
- A \$10.00 late fee is charged for any payment made after the 10<sup>th</sup> of the month.
- A \$20.00 returned check fee will apply to any tuition payment check that is returned.
- CWG-WWS reserves the right to place any student on a wait list whose tuition is 2 months delinquent
- There is limited scholarship/tuition assistance available. The Donna Purkhiser Scholarship and the Gregory McDevitt Scholarship are awarded based on documented need. All information will be kept completely confidential. Application forms will be available in March of 2026 and can be obtained in the school office. They will be due by April 30th.
- Anyone in need of special payment terms should contact the director.

## WITHDRAWALS/REFUNDS

- Please notify the director in writing as soon as possible when a child is to be withdrawn.
- The registration fee is strictly non-refundable.
- Parents are responsible for tuition payments for the four school weeks following the child's last day of attendance or following the date of notification of withdrawal, whichever is later.
- If the notification of withdrawal occurs between June 1 and the Friday preceding Labor Day, parents are responsible for four weeks of tuition.
